SECTION 4: First-aid measures

4.1. Description of first aid measures

General information

If breathing is irregular, drowsiness, loss of consciousness or cramps: Call 911 and give immediate treatment (first aid).

Contact a doctor if in doubt about the injured person's condition or if the symptoms persist. Never give an unconscious person water or other drink.

Inhalation

Upon breathing difficulties or irritation of the respiratory tract: Bring the injured person into fresh air. Make sure the injured person is continuously monitored. 4.2. Most important symptoms and effects, both acute and delayed

Intolerance to alcohol can occur up to 4 days after exposure to dimethylformamide. Dimethylformamide is considered to be a potent liver toxin. Vomiting, Diarrhoea, Abdominal pain.

SECTION 5: Fire-fighting measures
